9. **NEW BUSINESS**

**A. Approval of Request to Cancel FMPA Contract**

**NOTICE OF CONVERSATION TO CONTRACT RATE OF DELIVERY  
PURSUANT TO SECTIONS 3 AND 23, ALL REQUIREMENTS POWER  
SUPPLY CONTRACT BETWEEN FMPA & CITY OF FORT MEADE**

Attorney Tom Cloud described the City's contract with Florida Municipal Power Association as outrageous and further stated that the City may be better off to declare bankruptcy then to litigate the contract. Should the City lose in litigation the City would be responsible for paying FMPA's legal fees in addition to our own. FMPA is a cooperative of cities, therefore if the City of Fort Meade sues FMPA they are also suing themselves. FMPA is totally unregulated, the only organization that Mr. Cloud knows of that does not have to answer to any government or state agency. Attorney Cloud stated that he could not in good conscience advice Fort Meade to sue FMPA because it would be a war that the City cannot win. The letter to Mr. Nick Guarriello is the first step in trying to get out of the contract with FMPA. However, because of FMPA's contract this letter merely states that the City will not be purchasing future power from FMPA in 30 years. This is the first step towards getting out of the contract. Attorney Cloud stated that the second step for the City to take in trying to get out of the contract is to call attention in a very public way to FMPA's contract with the City and the absurdness of the agreement. Third step is to start writing your Congressmen, Governor and Representatives to make them aware of the problems with FMPA.

**Motion Bell, Seconded Watts to forward the Notice of Conversation letter to FMPA immediately.**

**Motion carried with all yeas.**

**Motion Bell, Seconded Watts to transfer the City of Fort Meade's electric to an outside authority.**

**Motion passed with all yeas.**

**B. General Engineering & Management Consulting Proposal for Power Services**

City Manager explained that the proposal is for a rate stabilization study to enable the City to eventually set aside funds to keep the electrical rates stable without the extreme month to month fluctuations.

**Motion Bell, Seconded Watts to approve the hiring of Power Services for a rate stabilization study.**

**Motion carried with all yeas.**

**10. CITY MANAGER COMMENTS:**

FMPA's Business Model Review Committee is meeting Friday, July 31 in Orlando which Mr. Hilliard plans to attend as a member of the committee.

All five (5) of the outstanding claims for hurricane damage with FEMA have been closed out successfully.

The sewer rehabilitation project is on schedule and will be completed on time. Due to the low bid prices on this project we will be able to include some additional work outside the contract.

**11. CITY FINANCE DIRECTOR COMMENTS:**

Mr. Parker reported that the fiscal year 2008 audit is in progress and no major issues have been identified at this point.

FMPA has confirmed the TECO true-up due for 2008 is \$178,749.00.

**13. CITY COMMISSION COMMENTS:**

Commissioner Bell stated that the Forth of July celebration was very good. She did however believe that a contract should be drawn up between the Chamber and the City making attendance mandatory at special events and holidays for the Chamber Director.

Mayor Elliott stated that streets and sidewalks in the City are badly in need of repair, some sidewalks have never been repaired from Hurricane Charlie in 2004.
